Minutes of SC meeting (phone) – 13 September 2013

1. ACCESS September workshops update

- **Summerschool in Bremen** (23-27 September 2013): 20 students and 10-15 lecturers are expected - Agenda, presentation of lecturers, notes from discussions and breakout sessions will be released and an article on the NL on the results of summerschool by students could be provided following the workshop. The last day will be a joint meeting with **WP5 workshop** (26-27 September 2013) with representatives of all the WPs
- **WP4 workshop in Hamburg** (17-18 September 2013) – only 13 of the 33 persons in the WP will come - Minutes of the meeting and presentation will be provided after the workshop.
- **WP2 workshop in Hamburg** (17-18 September 2013) – 11 partners and 4 stakeholders will be represented. Minutes will be available after the workshops.
- **WP2/WP4 stakeholder workshop** (19 September)

2. Upcoming conferences

- Next ACCESS GA in Cambridge, UK, 3-7 March 2014 at BAS
- 2 meetings with the EU Arctic Information Centre coordinated by Paulaa Kankaanpää in Rovaniemi: one in October in Rovaniemi, one in Tromso in January during the Arctic frontiers. Agenda: a full day for Responding to change workshop; 2nd day: consultation with stakeholders (How ACCESS could participate?); last 2 days: conference with academic and stakeholders (JCG will circulate the conference details). Deadline of October to submit a paper – information need to be sent among ACCESS partners - 2 topics could be interested for ACCESS: Arctic health and Maritime operational challenges, see www.arctic-frontiers.com
- **Arctic Frontiers meeting 2014** important for ACCESS, partners should be encouraged to submit to science days, too. EU ArcRisk project (Arctic Pollutants and health) will have final conference on Arctic Frontiers 2014 science days.
- Meeting IMO in London 28 Feb. before the ACCESS GA to discuss Polar Code issues. Paul Berkman and Lawson B. will circulate the info as soon as they get it.
- Joachim has been invited by Russian to Arctic territorial dialogue in Salekhard.

3. Policy brief

Jeremy will circulate a final draft of Policy Brief on Oil spill.

5 out of 7 factsheets in preparation for the EUIAC could be interesting for ACCESS (topic overlap).

3 more topics need to be selected for ACCESS policy briefs. Suggestions:

- Black carbon (UPMC-LATMOS team)
- Food production (John, Max Troell and Anne-Sophie)

Subjects needs to be discussed during the next SC

4. Deliverables

- Recommendations from the Commission: Deliverables should be submitted even if the deliverable is not fully completed. A draft could be submitted in a first place and rejected by the Project Officer to amend it.
- Any more delays cannot be accepted
- MP prepared the list of deliverables delayed and due for the 3rd period. MP will send a reminder to urge partner responsible to send their feedbacks on the status of deliverables delayed.

5. ACCESS NL n°6

- Recommendation of the EU: NL must be shorter with more results (not too detailed)
- MK and JCG identified the potential topics from the report P2 – they will send the list to the SC.

6. AOB

Question was raised regarding the obligation to have WP meeting between the GA.

- ➔ This is not mandatory by the EU contract but this is strongly recommended. It is not enough for ACCESS WPs to meet only once a year during the ACCESS GA.
